IMPORTANT NOTE: If your organization would like to request a Display Table and is NOT one of the ministries of the Central States Synod or the ELCA, then special approval must be granted by the Central States Synod Council. Please submit your Request for Display Table—Registration Form by April 15, 2019 to Dawne Bockelman (dbockelman@css-elca.org). Please attach a one page summary which explains the purpose, vision and structure of the whole organization. Include whether the organization has a Not-for-Profit status and website information. This will enable the Synod Council to have a better understanding of the mission of your organization. The Synod Council will act on these requests at the respective meeting on 3/15/19 or 5/3/19. You will be notified of their decision by email. If approved by Synod Council, then a request for payment will follow at the appropriate time. It's best to submit your request early for a Display Table as space may be limited.
